All documents submitted in a **language different from English or from French** must be translated by a sworn translator into English or into French.

<p>1. Identity document currently valid: France: copy of national identity card or passport (both sides, legible and signed by the holder). Other countries: copy of national identity card issued by a state that is a member of EEA or OECD¹ or copy of passport. The copy must be certified and legalized (apostille) by the competent national authority.</p>
<p>2. Evidence of personal domicile (utility bills dated less than 3 months) France and EEE states: simple copy. Other countries: the copy must be certified and legalized (apostille) by the competent national authority.</p>
<p>3. Original extract of criminal record from the country of residence</p>
